**SECOND AMENDMENT
(BOS AGREEMENT NO. ____ - ____)**

This Second Amendment to Agreement No. 24-47 (“Second Amendment”) is made and entered into as of the last date signed below, by and between the County of Yolo (“County”) and American Medical Response West (“Contractor”), jointly referred to as the “Parties” herein.

WHEREAS, on or about December 29, 2023, the Parties entered into Agreement No. 24-47 (“Agreement”); and

WHEREAS, on or about February 14, 2024, the County exercised its option to extend the Agreement under the same terms and conditions via Option Letter #1; and

WHEREAS, on or about March 12, 2024, the Parties Amended the Agreement via the First Amendment; and

WHEREAS, the Parties would now like to amend the Agreement, as previously amended, to:

1. Revise **Paragraph III.B** to add funding in the amount of \$121,710 for a new contract maximum of \$608,550; and
2. Revise **Paragraph III.A.1. of Exhibit E** to update contact for County Risk Manager.

NOW, THEREFORE, THE PARTIES HEREBY AGREE AS FOLLOWS:

1. Paragraph III.B of the Agreement is hereby amended to read as follows:

A. Any other provision of this Agreement notwithstanding, the maximum payment obligation to Contractor through **June 30, 2024**, shall be no greater than **SIX HUNDRED EIGHT THOUSAND FIVE HUNDRED FIFTY DOLLARS (\$608,550)** specified as follows:

2. Paragraph III.A.1. of Exhibit E to the Agreement is hereby amended to read as follows:

3. Except as specifically amended by this Second Amendment, the Agreement shall remain in full force and effect according to its terms.




