**FIRST AMENDMENT  
(BOS AGREEMENT NO. ( \_\_\_ - \_\_\_ ))**

This First Amendment to Agreement No. 24-28 (“First Amendment”) is made and entered into as of the last date signed below, by and between the County of Yolo (“County”) and OLE Health, dba CommuniCare OLE (“Contractor”), jointly referred to as the “Parties” herein.

**WHEREAS**, on or about January 9, 2024, the Parties entered into Agreement No. 24-28 (“Agreement”); and

**WHEREAS**, the Parties would now like to amend the Agreement to:

1. Revise **Paragraph I.A.** to update the term of the Agreement to end on August 31, 2024; and
2. Revise **Paragraph III.B1.** to remove optional extension language and reduce funding in the amount of \$1,155,928.54 for a new contract maximum of \$344,071.46 by decreasing Fiscal Year (FY) 2024-25 in the amount of \$555,928.54 and removing funding for FY 2025-26; and
3. Revise **Paragraph IV.** to update language; and
4. Revise **Exhibit D** to update budget for FY 2024-25 and remove future budgets; and
5. Revise **Paragraph IV.A. of Exhibit F** to update County Risk Manager.

**NOW, THEREFORE, THE PARTIES HEREBY AGREE AS FOLLOWS:**

**1. Paragraph I.A.** of the Agreement is hereby amended to read as follows:

- A.** The term of this Agreement shall be from **January 1, 2024 through August 31, 2024** unless sooner terminated as provided in this Agreement.

**2. Paragraph III.B1.** of the Agreement is hereby amended to read as follows:

- B.** Any other provision of this Agreement notwithstanding, the maximum payment obligation to Contractor through **August 31, 2024**, shall be no greater than **THREE HUNDRED FORTY-FOUR THOUSAND SEVENTY-ONE DOLLARS AND FORTY-SIX CENTS (\$344,071.46)** specified as follows:

<b>Fiscal Year 2023-24</b> January 1, 2024 through June 30, 2024	<b>Fiscal Year 2024-25</b> July 1, 2024 through August 31, 2024	<b>Total</b>
\$300,000	\$44,071.46	<b>\$344,071.46</b>

**3. Paragraph IV.** of the Agreement is hereby amended to read as follows:

**IV. Specific County Authority**

**A. Director’s Authority:** The Director may issue any general notices regarding the administration of this Agreement.

**B. County Procurement Manager’s Authority:** The Yolo County Deputy Director/Manager of Procurement (“Procurement Manager”) may approve and execute amendments regarding allocation of funds between categories of services, scope of services, billing rates, and other contract language changes set forth elsewhere in this Agreement provided the modifications are






