

## SUBAWARD NO. 4517

### Amendment #1 to Yolo County Agreement No.23-21

THIS FIRST AMENDMENT to Yolo County Agreement No. 23-21 (American Rescue Plan, Yolo Crisis Nursery - New Facility Construction project) is made this 26th day of June, 2024 by and between the County of Yolo (“County”) and Yolo Crisis Nursery, Inc., a California nonprofit public benefit corporation (“Subrecipient”), who agree as follows:

#### RECITALS

WHEREAS, Subrecipient serves children in need by offering a variety of child abuse protection services including its signature programs Crisis and Respite Care, Wraparound Services for Families, and Specialized Infant Daycare and Preschool for children of families transitioning out of crisis and special needs children.

WHEREAS, on January 23, 2024, the Board of Supervisors approved Agreement No. 23-21 to award \$1,100,000 to SUBRECIPIENT for the construction of new crisis nursery in the City of Davis with increased capacity and enhanced service programs for children and families in the County.

WHEREAS, the \$1,100,000 awarded as part of the County’s Children, Youth, and Families Priority Category for the expenditure of American Rescue Plan (“ARP”) funds.

WHEREAS, Subrecipient has completed bidding for the new crisis nursery and anticipates completing construction in the Spring of 2025 but has a remaining funding gap of \$1.25 million due to construction costs exceeding initial estimates.

WHEREAS, on June 4, 2024, the Board of Supervisors approved reallocating certain ARP funds, including an additional allocation of \$200,000 to Subrecipient (Minute Order No. 24-54) to help close the funding gap for construction of Subrecipient’s new crisis nursery.

NOW THEREFORE, the parties hereby agree to amend the Agreement No. 23-21 as follows to reflect the increased subaward and amended budget.

#### AMENDED TERMS

1. Amount Funded. The total amount funded is hereby increased to a total of \$1,300,000.
2. Attachment 6 – Budget Information. Attachment 6 of Agreement No. 23-21 is hereby amended and replaced with Attachment 6 hereto to reflect the revised project budget with the additional \$200,000 ARP subaward funding.
3. Except as expressly amended, all other terms and conditions of Agreement No. 23-21 remain unchanged.


