## **FINAL NOTICE - INTENT TO LIEN**

May 7, 2024

Dear Mr. Eric Kilgore,

Our records indicate that your account with Recology Davis for solid waste, recycling, and organics collection services at 44470 Country Club Drive in Davis, is past due by more than 365 days, with a current balance owed in the amount of \$850.07. Under Yolo County Ordinance No. 1529, you are responsible for payment in full unless you have an approved exemption on file with Yolo County. The County has reviewed their records and does not show an approved exemption on file. Therefore, this letter is to inform you that if your account is not **paid in full by May 31, 2024**, a lien will be placed on your property tax bill to collect the amount owed.

The four quarterly billing statements sent to you by Recology serve as proper notice of the amount owed. In addition, this serves as 45 days' notice for the potential to lien. Per the Yolo County solid waste franchise agreement with Recology Davis, Section 6.2, it states "...in the event Contractor's for a one (1) year period to collect monies due from a Customer fail and Contractor can demonstrate to the County that Contractor attempted on at least four (4) documented occasions to solicit monies due from each delinquent account, then Contractor shall provide the County with the name and address of each delinquent account and amount due, and the County shall take responsibility for recovering the bad debt. Without limiting the permitted documentation, invoices that include notice of past-due amounts shall constitute such documentation, provided; however, that the Contractor provides a final notice to the Customer that their account will be turned over to the County to initiate a lien process to collect past due amounts. The County shall send a letter to each delinquent account requesting payment for Collection services and stating that in the event payment is not promptly received the County will put a lien on the property. If payment is not received, County shall initiate and comply with the legal procedure to put a lien on the property..."

If your account goes to lien, this may adversely affect your credit rating and show on your credit report for up to seven (7) years. A listing of properties and owners that go to lien will be published and reviewed by the Yolo County Board of Supervisors, for which you will be notified of the date of public hearing. Unfortunately, payments received on or after June 1, 2024, will only apply to your current billing statement and not to the lien amount placed on your property tax bill.

To avoid having a lien placed on your property, or if you feel you have received this letter in error, please contact Recology Davis immediately to obtain your past due balance information on your account. To remit payment, you may choose any one of the three options:
