

AGREEMENT NO. 24-___

(First Amendment to Agreement No. 20-171 with ICF Jones & Stokes, Inc, for Biological and Archeological/Paleontological Services at the Yolo County Central Landfill to revise the maximum compensation)

This First Amendment to Agreement No. 20-171 for Biological and Archeological/Paleontological Services at the Yolo County Central Landfill (“First Amendment”) is entered into this 27th day of August 2024, by and between the County of Yolo, a political subdivision of the State of California (“County”), and ICF Jones & Stokes, Inc, (“Contractor”), a Delaware corporation.

Recitals

WHEREAS, the County is authorized by Government Code Section 23004 to make contracts as necessary for the exercise of its powers; and

WHEREAS, the County is authorized by Government Code Section 31000 to contract with persons specially trained, experienced, knowledge and competent to perform special services such as engineering design and construction quality assurance; and

WHEREAS, the County circulated and distributed a Request for Proposals in 2020 for Biological and Archeological/Paleontological Services at the Yolo County Central Landfill; and

WHEREAS, Contractor was the top ranked firm and was awarded Yolo County Agreement No. 20-171, dated June 23, 2020); and

WHEREAS, the initial term of the Agreement has been extended through May 31, 2025 pursuant to the authorization in Section IX.A of the Agreement; and

WHEREAS, Additional services have been necessary due to cultural finds at the Yolo County Central Landfill Borrow Site which necessitate an increase in the maximum compensation authorized in the Agreement.

NOW, THEREFORE, IT IS HEREBY AGREED AS FOLLOWS:

1. The second paragraph of Section III.A of Agreement No. 20-171 is amended to increase the total maximum compensation to \$225,000 as follows:

Provided, however, that the total amount of compensation to be paid to Contractor for the services required by this Agreement shall not exceed two hundred twenty-five thousand dollars (\$225,000.00). In the determination of hourly fees, time allotments shall be calculated to one-tenth of an hour.

2. Except as specifically amended hereinabove, Agreement No. 20-171 shall remain in full force and effect according to its terms through May 31, 2025.
