

RESOLUTION NO. _____

(Resolution Increasing Appropriations in the Amount of \$22,600 to the EMSA-Ambulance Provider Contract Fines Cost Center)

WHEREAS, on or about September 24, 2024, the Board of Supervisors for the County of Yolo adopted a budget for 2024-25 for the Health and Human Service Agency (“HHSA”); and

WHEREAS, on or about March 26, 2024, HHSA entered into a revenue agreement with American Medical Response West for the provision of emergency ambulance services, advanced life support and critical care transports in the exclusive operating area of Yolo County for the period of April 1, 2024 through April 1, 2029 (“Agreement No. 24-104”); and

WHEREAS, pursuant to Agreement No. 24-104, HHSA receives reimbursement and compliance penalties to be used for EMS system enhancements; and

WHEREAS, the additional funding of \$22,600 was not included in the 2024-25 Adopted Budget for HHSA; and

WHEREAS, HHSA is requesting to include the redistribution amount of \$22,600 in the HHSA 2024-25 Adopted Budget; and

WHEREAS, it appears to be in the best interest of the County, its residents, and other customers, to accept the funds; and

WHEREAS, there would be no net fiscal impact to the County General Fund for Fiscal Year 2024-25 by making these adjustments; and

WHEREAS, Government Code section 29130 provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors.

NOW, THEREFORE IT IS HEREBY RESOLVED, ORDERED AND FOUND by the Board of Supervisors of the County of Yolo, State of California, that the Chief Financial officer is authorized to increase the budget for fiscal year 2024-25 as follows:
