**RESOLUTION OF THE YOLO COUNTY BOARD OF SUPERVISORS  
APPOINTING DIRK BRAZIL AS AN INTERIM COUNTY ADMINISTRATIVE  
OFFICER  
(Government Code Section 21221(h))**

**WHEREAS**, Government (Gov.) Code section 21221(h) of the Public Employees' Retirement Law permits the governing body to appoint a CalPERS retiree to a vacant position requiring specialized skills during recruitment for a permanent appointment, and provides that such appointment will not subject the retired person to reinstatement from retirement or loss of benefits so long as it is a single appointment that does not exceed 960 hours in a fiscal year; and

**WHEREAS**, the Yolo County Board of Supervisors desires to appoint Dirk Brazil as an interim appointment retired annuitant to the vacant position of County Administrative Officer under Gov. Code section 21221(h), effective October 14, 2024; and

**WHEREAS**, the Yolo County Board of Supervisors, the County of Yolo and Dirk Brazil certify that Dirk Brazil has not and will not receive a Golden Handshake or any other retirement-related incentive; and

**WHEREAS**, an appointment under Gov. Code section 21221(h) requires that the retiree is appointed into the interim appointment during recruitment for a permanent appointment; and

**WHEREAS**, the governing body authorized the search for a permanent appointment on October 8, 2024; and

**WHEREAS**, this Gov. Code section 21221(h) appointment shall only be made once and therefore will end in accordance with the terms and provisions of the Employment Agreement approved concurrently herewith; and

**WHEREAS**, the entire Employment Agreement between Dirk Brazil and the County of Yolo has been reviewed by the Yolo County Board of Supervisors and is attached to the staff report accompanying this Resolution; and

**WHEREAS**, the compensation paid to retirees cannot be less than the minimum nor exceed the maximum monthly base salary paid to other employees performing comparable duties, divided by 173.333 to equal the hourly rate; and

**WHEREAS**, the maximum base salary for this position is \$27,052.13 and the hourly equivalent is \$156.07; the minimum base salary for this position is \$27,052.13 and the hourly equivalent is \$156.07; and

**WHEREAS**, the hourly rate paid to Dirk Brazil will be \$156.07; and

**WHEREAS**, Dirk Brazil has not and will not receive any other benefit, incentive, compensation in lieu of benefit or other form of compensation in addition to this hourly pay rate; and

**THEREFORE, BE IT RESOLVED THAT** the Yolo County Board of Supervisors hereby certifies the nature of the employment of Dirk Brazil as described herein and detailed in the accompanying Employment Agreement and that this appointment is necessary to fill the critically needed position of County Administrative Officer for the County of Yolo commencing October 14, 2024 because of the prior resignation of Gerardo Pinedo, who served as County Administrator through October 4, 2024.
