FIFTH AMENDMENT
(BOS AGREEMENT No: ____ - ____)

This Fifth Amendment to Agreement No. 21-19 (“Fifth Amendment”) is made and entered into as of the last date signed below, by and between the County of Yolo (“County”) and North Valley Behavioral Health, LLC (“Contractor”), jointly referred to as the “Parties” herein.

WHEREAS, on or about January 26, 2021, the Parties entered into Agreement No. 21-19 (“Agreement”); and

WHEREAS, on or about February 7, 2023, the Parties amended the Agreement via the First Amendment; and

WHEREAS, on or about June 6, 2023, the Parties further amended the Agreement via the Second Amendment; and

WHEREAS, on or about November 7, 2023, the Parties further amended the Agreement via the Third Amendment; and

WHEREAS, on or about August 12, 2024, the County exercised its option to extend the Agreement under the same terms and conditions via Option Letter #1; and

WHEREAS, on or about August 24, 2024, the Parties further amended the Agreement via the Fourth Amendment; and

WHEREAS, the Parties would now like to amend the Agreement, as previously amended, to:

1. Revise **Paragraph III.B.1.** to add funding in the amount of \$84,158 for Fiscal Year (FY) 2024-25 for a new contract maximum of \$4,400,158; and
2. Revise **Paragraph XVIII.B. of Exhibit C** to update County’s Contract Administrator.

NOW, THEREFORE, THE PARTIES AGREE AS FOLLOWS:

1. **Paragraph III.B.1.** of the Agreement is hereby amended to read as follows:

B.1. Any other provision of this Agreement notwithstanding, the maximum payment obligation to Contractor through **June 30, 2025**, shall be no greater than **FOUR MILLION FOUR HUNDRED THOUSAND ONE HUNDRED FIFTY-EIGHT DOLLARS (\$4,400,158)** specified as follows:

FY 2020-21 January 26, 2021 through June 30, 2021	\$384,000
FY 2021-22 July 1, 2021 through June 30, 2022	\$876,000
FY 2022-23 July 1, 2022 through June 30, 2023	\$976,000
FY 2023-24 July 1, 2023 through June 30, 2024	\$1,040,000
FY 2024-25 July 1, 2024 through June 30, 2025	\$1,124,158
Total	\$4,400,158
