FIRST AMENDMENT TO AGREEMENT NO. 5050-2025-YCRC WITH THE YOLO CONFLICT RESOLUTION CENTER TO INCREASE THE MAXIMUM COMPENSATION FOR FY24-25

THIS FIRST AMENDMENT to Agreement No. 5050-2025-YCRC is made and entered into as of 14th day of January, 2025, by and between the County of Yolo, a political subdivision of the State of California (“County”) and the Yolo Conflict Resolution Center, a California not for profit organization (“Contractor”) who agree as follows.

RECITALS

WHEREAS, on or about August 21, 2024, the parties entered into an agreement for Contractor to provide services to the Probation youth and their families within the County of Yolo (Yolo Agreement No. 5050-2025-YCRC); and

WHEREAS, the parties wish to amend Agreement No. 5050-2025-YCRC to increase the maximum compensation.

NOW, THEREFORE IT IS HEREBY AGREED AS FOLLOWS:

AGREEMENT

1. Paragraph 4 of Agreement No. 5050-2025-YCRC is hereby amended to read as follows:

COMPENSATION

Subject to CONTRACTOR’S satisfactory and complete performance of all terms and conditions of this Agreement, and upon CONTRACTOR’S submission of an appropriate claim, COUNTY shall pay CONTRACTOR no more than \$205,719 as identified in Exhibit B – Revised FY24-25 Budget (attached).

2. Except as specifically amended hereinabove, Agreement No. 5050-2025-YCRC shall remain in full force and effect according to its terms.
