RECOMMENDED ACTION

FISCAL IMPACT

REASON FOR RECOMMENDED ACTION

Members of the WIB who desire to remain on the WIB must provide a subsequent application prior to the expiration of the current term of appointment. The term of several WIB members occurs on January 26, 2025: Leslie Rubalcava and Jeff Richard.

BACKGROUND

The WIB is comprised of 23 members who serve as an advisory committee to the Yolo County Board of Supervisors on local workforce development issues. The term of membership is four (4) years from the date of appointment, at which time the member must supply a subsequent application or the membership will cease if no application is received and approved. Per the Workforce Innovation and Opportunity Act, the membership must be comprised of the following representatives, Business, Workforce and Labor, Adult Education Literacy, Vocational Rehabilitation, Higher Education, Wagner-Peyser, and Economic Development. Staff to the WIB notified those members listed above with expiring terms of the requirement to provide a subsequent application.

The following members expressed a desire to remain on the WIB and have provided a subsequent WIB Membership Application: Leslie Rubalcava and Jeff Richard.

Appointment of Board members is based on Workforce Innovation Board (WIB) By-laws, supported by the Workforce Innovation and Opportunity Act. The term of appointment is based on WIB By-laws which state in section 8. a) "The term of office for each WIB members is four (4) years from the date of appointment by the Board of Supervisors." The Membership for Appointment is made by the Board of Supervisors, "The Yolo County Board of Supervisors shall make all appointments to the WIB after considering recommendations by the WIB and other interested parties."

AGENCY COORDINATION

Upon ratification by the WIB, the recommendation for appointment will be submitted to the County Board of Supervisors for approval by a majority vote.
