

RESOLUTION NO. _____

(A Resolution increasing the Sheriff's Office Patrol Division FY 2024-25 Appropriations by \$26,086 for the California State Parks' Off-Highway Motor Vehicle Recreation Program – Law Enforcement)

WHEREAS, the Yolo County Sheriff's Office desires to participate in the Off-Highway Motor Vehicle Recreation Grants and Cooperative Agreements Program administered by the California State Parks Department to "provide for well managed OHV Recreation" to be funded from funds made available through the state of California; and

WHEREAS, the California State Parks' Off-Highway Motor Vehicle Recreation Program has made available funding for the 2024-25 fiscal year for Law Enforcement; and

WHEREAS, the Yolo County Board of Supervisors now authorizes participation in and approves the receiving of grant funding from the Off-Highway Motor Vehicle Recreation Program and authorizes Tom A. Lopez, Yolo County Sheriff-Coroner-Public Administrator, to have signature authority on all program-related documents; and

WHEREAS, the Yolo County Sheriff's Office did not budget the total grant award required by the California State Parks' Off-Highway Motor Vehicle Recreation Program. Match funds will come from in-kind services (\$8,695) for the 2024-25 fiscal year; and

WHEREAS, the Sheriff's Office has identified a need to fund overtime hours for OHV patrolling and purchase supplies identified in the 2024-25 fiscal year Law Enforcement Grant Agreement; and

WHEREAS, the grant award agreement will provide, inter alia, that: (1) grant funds supplement and not supplant existing expenditures; (2) the County bears responsibility for any liability arising out of the performance of the agreement; and (3) the award is not subject to any local hiring freezes; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW, THEREFORE, BE IT RESOLVED as follows:

1. The forgoing recitals are true and correct.
2. The Chief Financial Officer is authorized to amend the budget for the 2024-25 fiscal year as follows:
