

RESOLUTION NO.

Resolution Authorizing the Yolo County Agricultural Commissioner/Sealer of Weights and Measures to Execute Memoranda of Understanding and Agreements with the California Crop Improvement Association, California Department of Food and Agriculture and California Rice Commission for Fiscal Years 2025/26 and 2026/27

WHEREAS, it is a general requirement that certain contracts or agreements entered into by the Yolo County Agricultural Commissioner/Sealer of Weights and Measures’ Office be signed by the Chair or an authorized designee of the Board of Supervisors; and

WHEREAS, to expedite the processing of various contacts anticipated by the Agricultural Commissioner/Sealer of Weights and Measures’ Office in the 2025/26 and 2026/27 fiscal years, the Board of Supervisors is amenable to delegating authority to sign the agreements described below:

NOW THEREFORE, the Yolo County Board of Supervisors (“Board”) hereby resolves as follows:

1. The Board authorizes the Yolo County Agricultural/Commissioner/Sealer of Weights and Measures to execute the agreements listed below and any amendments to these agreements during Fiscal Year 2025/26 and Fiscal Year 2026/27 on behalf of Yolo County. A copy of each executed agreement shall be filed with the Clerk of the Yolo County Board of Supervisors.
