**FOURTH AMENDMENT  
(BOS AGREEMENT NO. \_\_\_\_ - \_\_\_\_)**

This Fourth Amendment to Agreement No. 23-149 (“Fourth Amendment”) is made and entered into as of the last date signed below, by and between the County of Yolo (“County”) and North Valley Behavioral Health LLC (“Contractor”), jointly referred to as the “Parties” herein.

**WHEREAS**, on or about August 30, 2023, the Parties entered into Agreement No. 23-149 (“Agreement”); and

**WHEREAS**, on or about February 27, 2024, the Parties amended the Agreement via the First Amendment; and

**WHEREAS**, on or about June 4, 2024, the Parties further amended the Agreement via the Second Amendment; and

**WHEREAS**, on or about September 10, 2024, the Parties further amended the Agreement via the Third Amendment; and

**WHEREAS**, the Parties would now like to amend the Agreement, as previously amended, to:

1. Revise **Section I.** to extend the term of the Agreement through June 30, 2026; and
2. Revise **Paragraph III.D. of Article 1.** to add funding in the amount of \$4,750,232 by adding \$1,374,716 for Fiscal Year (FY) 2024-25 and adding \$3,375,516 for FY 2025-26 for a revised contract maximum of \$10,628,302; and
3. Delete **Paragraph III.E. of Article 1.** in its entirety; and
4. Revise **Paragraph 2.d.i of Exhibit D** to update County Risk Manager.

**NOW, THEREFORE, THE PARTIES HEREBY AGREE AS FOLLOWS:**

1. **Section I.** of the Agreement is hereby amended to read as follows:

**I. TERM**

The term of this Agreement shall be from **July 1, 2023 through June 30, 2026**, unless sooner terminated as provided for in Article 2, Section VII. of this Agreement.

2. **Paragraph III.D. of Article 1** of the Agreement is hereby and amended to read as follows:

**D.** The maximum financial obligation of County under this Agreement for the term of this Agreement shall not exceed **TEN MILLION SIX HUNDRED TWENTY-EIGHT THOUSAND THREE HUNDRED TWO DOLLARS (\$10,628,302)**, as follows:

These amounts are not guaranteed but shall be paid only for services rendered and received in conformance with this Agreement.

3. Paragraph III.E. of Article 1. of the Agreement is deleted in its entirety.

4. Paragraph 2.d.i of Exhibit D to the Agreement is hereby amended to read as follows:

- i. Stacy Leasure, County’s Risk Manager/Safety Officer [Stacy.Leasure@yolocounty.gov](mailto:Stacy.Leasure@yolocounty.gov) and [Risk.Mgmt@yolocounty.gov](mailto:Risk.Mgmt@yolocounty.gov); and

5. Except as specifically amended by this Fourth Amendment and any prior amendments, the Agreement shall remain in full force and effect according to its terms.


