**THIRD AMENDMENT
(BOS AGREEMENT NO. ____ - ____)**

This Third Amendment to Agreement No. 23-317 (“Third Amendment”) is made and entered into as of the last date signed below, by and between the County of Yolo (“County”) and C.O.R.E. Medical Clinic, Inc. (“Contractor”), jointly referred to as the “Parties” herein.

WHEREAS, on or about February 7, 2024, the Parties entered into Agreement No. 23-317 (“Agreement”); and

WHEREAS, on or about May 8, 2024, the County exercised its option to extend the Agreement under the same terms and conditions via Option Letter #1; and

WHEREAS, on or about September 10, 2024, the Parties amended the Agreement via the First Amendment; and

WHEREAS, on or about October 14, 2024, the Parties further amended the Agreement via the Second Amendment; and

WHEREAS, the Parties would now like to amend the Agreement, as previously amended, to:

1. Revise **Section I. of Article 1.** to extend term of the Agreement through June 30, 2026, and update available optional extensions; and
2. Revise **Paragraph III.D.1. of Article 1.** to increase funding in the amount of \$2,400,000 for a new contract maximum of \$4,347,030.16 by adding \$600,000 for Fiscal Year (FY) 2024-25 and adding \$1,800,000 for FY 2025-26; and
3. Revise **Paragraph III.D.2. of Article 1.** to update the remaining option years and lifetime maximum; and
4. Revise **Paragraph III.A. of Article 2.** to update HHS Director contact information; and
5. Revise **Section III. of Exhibit A.1** to update target population regarding youth eligibility for the Narcotic Treatment Program; and
6. Revise **Paragraph IV.B.7.b.ii. of Exhibit A.1** to update age requirements for Medicated Assisted Treatment-Naltrexone Treatment Services; and
7. Revise **Paragraph 2.d.i. of Exhibit D** to update County Risk Manager.

NOW, THEREFORE, THE PARTIES HEREBY AGREE AS FOLLOWS:

1. **Section I. of Article 1.** of the Agreement is hereby amended to read as follows:

I. TERM

The term of this Agreement shall be from **January 1, 2024 through June 30, 2026** unless sooner terminated as provided for in Article 2, Section VII. of this Agreement. At the County’s option, this Agreement may be extended for two (2) additional twelve (12) month periods and one (1) additional six (6) month period on the same terms and conditions as set forth in this Agreement upon written notice to the Contractor by the Yolo County Health and Human Services Agency Director or their designee (“Director”).

2. Paragraph III.D.1. of Article 1 of the Agreement is hereby amended to read as follows:

D.1. The maximum financial obligation of County under this Agreement for the term of this Agreement shall not exceed **FOUR MILLION THREE HUNDRED FORTY-SEVEN THOUSAND THIRTY DOLLARS AND SIXTEEN CENTS (\$4,347,030.16)** as follows:

Fiscal Year 2023-24 January 1, 2024 through June 30, 2024	Fiscal Year 2024-25 July 1, 2024 through June 30, 2025	Fiscal Year 2025-26 July 1, 2025 through June 30, 2026	Total
\$747,030.16	\$1,800,000.00	\$1,800,000	\$4,347,030.16

These amounts are not guaranteed but shall be paid only for services rendered and received in conformance with this Agreement.

3. Paragraph III.D.2. of Article 1. of the Agreement is hereby amended to read as follows:

D.2. Option Years: The County may exercise its option to extend the term of the Agreement pursuant to Paragraph I. above. In the event that the County elects to exercise an option, County shall notify the Contractor in writing. The notice shall include the revised agreement term, approved funding amount to be added to the Agreement; and revised agreement maximum payment obligation, subject to the maximums set forth below:

In no event shall the term of the Agreement extend beyond **December 31, 2028**, nor shall the total contract maximum exceed the amount of **SEVEN MILLION FORTY-SEVEN THOUSAND THIRTY DOLLARS AND SIXTEEN CENTS (\$7,047,060.16)**, unless otherwise agreed to in writing by the parties and in conformity with the then-current Yolo County Procurement Policy approved by the Yolo County Board of Supervisors.

4. Paragraph III.A. of Article 2. of the Agreement is hereby amended to read as follows:

A. All notices shall be deemed to have been given when made in writing and delivered or mailed to the respective representatives of County and Contractor at their respective addresses as follows:

5. Section III. of Exhibit A.1 to the Agreement is hereby amended to read as follows:

III. TARGET POPULATION

Substance Use disorder treatment services will be provided to any eligible Yolo County resident referred through an access point established by Yolo County or directly requesting services through the provider and will include, but not be limited to the following populations/programs: CalWORKs; Child Welfare Services; Perinatal; Probation Department, Criminal Justice Involved (AB109), including PC1000; Indigent; and co-occurring severely mentally ill and substance using members.

Youth under the age of 18 are eligible for admission to the NTP program. Youth under 16 admitted to the NTP program must have consent of a parent or legal guardian for admission.

6. Paragraph IV.B.7.b.ii of Exhibit A.1 to the Agreement is hereby amended to read as follows:

ii. Is at least 16 years of age with parent/guardian consent for youth ages 16-17.

7. Paragraph 2.d.i of Exhibit D to the Agreement is hereby amended to read as follows:

i. County's Risk Manager/Safety Officer at Risk.Mgmt@yolocounty.gov; and

4. Except as specifically amended by this Third Amendment and any prior amendments the Agreement shall remain in full force and effect according to its terms.
