

**YOLO COUNTY AGREEMENT NO. \_\_\_\_\_**

(Fourth Amendment to Agreement No. 4151 with Patrol Solutions relating to Security Services)

THIS Fourth Amendment to Agreement No. 4151 is made and entered into as of the 4th day of June 2025, by and between the County of Yolo, a political subdivision of the State of California (“County”), and Patrol Solutions, LLC, a California limited liability company, dba Patrol Solutions (“Contractor”), who agree as follows.

**WHEREAS**, on or about December 1, 2021, the parties entered into an agreement for Contractor to provide security services at various locations throughout the County (Yolo County Agreement No. 4151); and

**WHEREAS**, on or about July 12, 2022, the parties amended Agreement No. 4151 to extend the current contract term for one additional year through June 30, 2023, with options to renew the Agreement for up to four additional one-year terms and to increase the maximum compensation, effective July 1, 2022, to \$250,000 per fiscal year; and

**WHEREAS**, on or about October 10, 2023, the parties entered into an agreement to extend the current contract term for one additional year through June 30, 2024, with option to renew the Agreement for up to three additional one-year terms and in increase the maximum compensation, effective July 1, 2023, to \$255,000 per fiscal year; and

**WHEREAS**, on or about July 9, 2024, the parties entered into an agreement to extend the current contract term for one additional year through June 30, 2025, with option to renew the Agreement for up to two additional on-year terms and increase the maximum compensation, effective July 1, 2024, to \$800,000 per fiscal year; and

**WHEREAS**, the parties wish to amend Agreement No. 4151 to increase the annual contract amount not to exceed \$900,000 for fiscal year 2024-25; and

**NOW, THEREFORE, IT IS HEREBY AGREED AS FOLLOWS:**

1. Paragraph **II.** of Agreement No. 4151 is hereby amended to read as follows:

**II. COMPENSATION AND REIMBURSEMENT OF EXPENSES**

- A. For the services described in Paragraph I above, and subject to the condition that the services have been completed in a manner satisfactory to the Director or his/her designee, Contractor shall be compensated as follows:

Contractor agrees to provide awarded items and/or services as specified in the RFP document at the rates set forth in Exhibit C thereto (Cost Proposal) through the term of the Agreement.

Provided, however, that the total amount of compensation to be paid to Contractor for the services required by this Agreement shall not exceed Nine Hundred Thousand Dollars (\$900,000) through June 30, 2025.

- 2. The Parties further confirm that they have exercised the option to the extend Agreement No. 4151 for one additional year pursuant to Paragraph **VII., subsection A.**, of Agreement No. 4151. The Agreement now expires on June 30, 2025, subject to the remaining one-year options to extend in Paragraph VII., subsection A.
  
- 3. Except as specifically amended hereinabove, Agreement No. 4151 shall remain in full force and effect according to its terms.
