(Resolution increasing the Fiscal Year 2024-25 Budget for the 1991 Realignment Family Support Subaccount fund (1025) in the Amount of \$2,552,203)

**WHEREAS**, on or about September 24, 2024, the Board of Supervisors for the County of Yolo adopted a budget for 2024-25 for the Health and Human Service Agency (“HHSA”); and

**WHEREAS**, on June 10, 2025, the Board of Supervisors for the County of Yolo approved the 3<sup>rd</sup> Quarter Budget Monitor report, adopting a budget resolution amending the 2024-25 revenues and appropriations; and

**WHEREAS**, this funding was not included in the 2024-25 Adopted Budget for HHSA; and

**WHEREAS**, the 1991 Realignment Family Support Subaccount fund (1025) revenue and appropriations were not part of the 3<sup>rd</sup> quarter budget monitoring report; and

**WHEREAS**, HHSA is requesting to include the amount of \$2,552,203 in the HHSA 2024-25 Fiscal Year Budget; and

**WHEREAS**, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors.

**NOW, THEREFORE IT IS HEREBY RESOLVED, ORDERED AND FOUND** by the Board of Supervisors of the County of Yolo, State of California, as follows:

1. The foregoing recitals are true and correct.
2. The Chief Financial Officer is authorized and directed to amend the budget for fiscal year 2024-25 as follows:
