

AGREEMENT NO. 25-___

(First Amendment to Agreement 23-75 with Holt of California for maintenance of the landfill gas-to-energy engines and generators at the Yolo County Central Landfill to revise the maximum compensation and extend the contract term)

This First Amendment to Agreement 23-75 for maintenance of the landfill gas-to-energy engines and generators at the Yolo County Central Landfill is entered into this 26th day of August, 2025, by and between the County of Yolo, a political subdivision of the State of California (“County”), and Holt of California, a California corporation (“Contractor”).

Recitals

WHEREAS, the County entered into Agreement No. 23-75, dated April 18, 2023, with Holt of California, for maintenance of the landfill gas-to-energy engines and generators at the Yolo County Central Landfill; and

WHEREAS, the initial three-year term of the Agreement is due to expire on December 31, 2025 and has the option of two, one-year extensions, pursuant to Section IX.A of the Agreement;

WHEREAS, the Director of the Integrated Waste Management Division has the authority to extend the contract for up to two one-year periods pursuant to the authorization in Section IX.A of the Agreement and desires to extend the contract through December 31, 2027, corresponding to the end of the second one-year extension.

WHEREAS, additional services have been necessary due to greater than anticipated maintenance requirements;

WHEREAS, the addition services and contract extension necessitate an increase in the Basic Services total compensation from \$3,225,000 established for the initial 3-year contract period, ending December 31, 2025, to \$6,225,000 for the extended contract the term, ending December 31, 2027.

NOW, THEREFORE, IT IS HEREBY AGREED AS FOLLOWS:

1. Section III.A of Agreement No. 23-75 is amended to increase the total maximum compensation as follows:
 - A. The total compensation for the tasks set forth in Article I shall not exceed \$6,225,000 (Basic Services).
2. Section IX.A of Agreement No. 23-75 is amended to extend the term of the agreement as follows:
 - A. The term of this Agreement shall be from April 18, 2023, through December 31, 2027, unless sooner terminated as hereinafter provided. No further extensions are authorized unless approved by the County Board of Supervisors with a written amendment to the Agreement.

3. Except as expressly amended herein, Agreement No. 23-75 remains in full force and effect.
