(Resolution Authorizing Acceptance of WIOA Subgrant Agreement No. AA611045)

**WHEREAS**, the County of Yolo ("County") has been designated to receive a Workforce Innovation and Opportunity Act ("WIOA") Subgrant from the State of California Employment Development Department ("EDD") to continue to fund programs to provide employment and training services to Yolo County residents; and

**WHEREAS**, EDD has issued WIOA Subgrant Agreement No. AA611045 ("Agreement"); and

**WHEREAS**, the term of Agreement is from April 1, 2025 through June 30, 2027 in the amount of \$1,462,091; and

**WHEREAS**, there are no matching funds requirements for this Grant; and

**WHEREAS**, it is in the best interest of County, its residents and its clients to enter into the Agreement.

**NOW, THEREFORE, BE IT RESOLVED THAT:**

1. Each of the foregoing recitals is true and correct.
2. County is hereby authorized and directed to accept WIOA funding under Agreement and any and all subsequent amendments or revisions thereto.
3. The Chair of the Board of Supervisors is authorized to execute the Agreement to receive WIOA funds in the amount of \$1,462,091 for the period of April 1, 2025 through June 30, 2027.
4. County Deputy Director of General Services/Manager of Procurement, or designee, is authorized to act on behalf of County in connection with the Agreement and to enter and accept any financial or non-financial amendments and revisions to Agreement upon approval as to form by County Counsel.
5. Director of Yolo County Health and Human Services Agency, or designee, is authorized to sign any WIOA fiscal and program reports and forms required under the Agreement, including reports and forms required under any extensions or amendments thereto.
6. County shall be subject to the terms and conditions specified in Agreement will use the funds in accordance with applicable rules and laws, and pursuant and subject to, all of the terms and provisions applicable to WIOA agreements through the EDD.
