Honorable Board of Supervisors:

The Knights Landing Ridge Drainage District ("District") respectfully requests the Yolo County Board of Supervisors appoint Bradley Pollock and Emily Reinhart to the office of Commissioner of the District at the next regularly-scheduled meeting of the Board of Supervisors.

The terms of two commissioners expire on December 31, 2025. As such, the District published Notice of an Election and Call for Nominating Petitions in the Woodland Daily Democrat on August 22, 2025. The number of nomination petitions received by the District at the deadline to submit nomination petitions did not exceed the number of seats up for election. The District then published a Notice of No Election in the Woodland Daily Democrat on September 9, 2023. 


