Dear Clerk of the Board:

This office serves as general counsel to Reclamation District No. 1600 ("RD 1600"), and on RD 1600's behalf, respectfully requests that the Yolo County Board of Supervisors appoint Ammy Reyes to the office of Trustee of RD 1600 at the next regularly scheduled meeting of the Board of Supervisors.

The terms of one trustee expires on December 1, 2025. As such, RD 1600 published a Notice of General District Election and Call for Nominating Petitions. Proof of publication of the Notice of General District Election and Call for Nominating Petitions is attached. As the number of qualifying nomination petitions did not exceed the number of seats available, no election will be held pursuant to Water Code section 50740.
