I am writing this letter on behalf of Reclamation District No. 765 (District) requesting that the County Board of Supervisors appoint the following trustees to serve on the District board for the terms referenced:

Patrick Markham	Four-Year Term (expiring December 7, 2029)

The District caused the Woodland Daily Democrat to publish a Notice Calling for Nomination Petitions on August 30, 2025, notifying the public of the election of trustees and requesting nominating petitions from interested parties on or before September 11, 2025. 


