

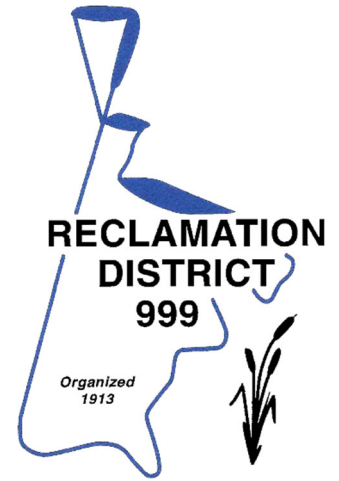

The term of two District trustees expire this year. At the conclusion of the nominating petition-filing period, two petitions had been filed to fill the vacancies:
