**Resolution Amending the District Attorney, Probation, Public Defender and Sheriff’s Department Adopted Budget for FY25-26 in the Amount of \$173,845 for the Justice Assistance Grant (JAG) from the State Board of Community Corrections**

**WHEREAS**, the Yolo County law enforcement departments (District Attorney, Probation, Public Defender and Sheriff) applied for and were awarded Justice Assistance Grant (JAG) funds in the amount of \$173,845 that provides funding for equipment and training to improve the programs operated by the various Yolo County law enforcement departments in the criminal justice system; and

**WHEREAS**, the grant award is a one year award beginning October 1, 2025 through September 30, 2026; and

**WHEREAS**, said funds were not included in the appropriations of the departments mentioned above and, therefore, this budget resolution amends the District Attorney, Probation, Public Defender and Sheriff’s Department Adopted Budget for FY25-26 in the amount of \$173,845 to fund various equipment and training programs, and

**WHEREAS**, section 29125 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

**NOW, THEREFORE BE IT RESOLVED** that the Department of Financial Services is authorized to adjust the budget in the amount of \$173,845:
