COVER SHEET

1. This Participation Agreement Amendment No. 1 ("Amendment 1") shall become effective upon execution by and between Yolo County ("Participant") and the California Mental Health Services Authority ("CalMHSA").

3. The maximum amount payable under the Agreement shall not exceed **One Hundred Forty-One Thousand Seven Hundred Ninety-Two Dollars (\$141,792.00)** during the term of the Agreement.



Modifications to the Agreement

The Agreement is hereby modified as described herein below effective upon execution of this Amendment 1:

1. **Cover Sheet, Section 4 (Term of Services)** is hereby modified with the following:
This Agreement shall become effective upon final execution by both Parties hereto and shall cover the period of July 1, 2025 through June 30, 2026.
2. **Cover Sheet, Section 6 (Maximum Funding)** is hereby modified with the following:
The maximum funding amount payable under this Agreement shall not exceed **One Hundred Forty-One Thousand Seven Hundred Ninety-Two Dollars (\$141,792.00)** for the stated services during the term of the Agreement.
3. **Exhibit A – Section IV (Program Funding)** is hereby deleted in its entirety and replaced with the following:
Maximum program funding under this Agreement shall not exceed the Not to Exceed (“NTE”) amount set forth below for all the stated services during the term of the Agreement:

Notes:

The updated NTE amount is calculated based on county’s highest annual utilization from the last two fiscal years and an added overage allowance to take into account annual increases in utilization during the term of this Agreement.

4. **Exhibit B – Section III.A (Duration, Term and Amendment)** is hereby modified with the following:
A. This Agreement shall become effective upon final execution by both Parties hereto and shall cover the period from July 1, 2025 through June 30, 2026, unless earlier terminated or extended as provided below.
