**FOURTH AMENDMENT
(BOS AGREEMENT NO. ____ - ____)**

This Fourth Amendment to Agreement No. 23-152 (“Fourth Amendment”) is made and entered into as of the last date signed below, by and between the County of Yolo (“County”) and OLE Health, dba CommuniCare OLE (“Contractor”), jointly referred to as the “Parties” herein.

WHEREAS, on or about June 27, 2023, the Parties entered into Agreement No. 23-152 (“Agreement”); and

WHEREAS, on or about October 24, 2023, the County, CommuniCare Health Centers and CommuniCare OLE entered into a Consent to Assignment and Novation agreement formally assigning OLE Health, dba CommuniCare OLE, rights and obligations under Agreement 23-153 to CommuniCare OLE effective October 1, 2023; and

WHEREAS, on or about May 21, 2024, the Parties amended the Agreement via the First Amendment; and

WHEREAS, on or about January 21, 2025, the Parties further amended the Agreement via the Second Amendment; and

WHEREAS, on or about May 1, 2025, the County exercised its option to extend the term of the Agreement under the same terms and conditions; and

WHEREAS, on or about October 4, 2025, the Parties further amended the Agreement via the Third Amendment; and

WHEREAS, the Parties would now like to amend the Agreement, as previously amended, to:

1. Revise **Paragraph III.D. of Article 1** to reduce funding in the amount of \$56,250 for Fiscal Year (FY) 2025-26 for a new contract maximum of \$888,750; and
2. Revise **Section II. of Exhibit B.2** to update the Budget for FY 2025-26 and number the paragraphs for ease of reference.

NOW, THEREFORE, THE PARTIES HEREBY AGREE AS FOLLOWS:

1. **Paragraph III.D. of Article 1** of the Agreement is hereby amended to read as follows:

D. The maximum financial obligation of County under this Agreement for the term of this Agreement shall not exceed **EIGHT HUNDRED EIGHTY-EIGHT THOUSAND SEVEN HUNDRED FIFTY DOLLARS (\$888,750)**, as follows:

\$315,000	\$315,000	\$258,750	\$888,750

These amounts are not guaranteed but shall be paid only for services rendered and received in conformance with this Agreement.

3. Except as specifically amended by this Fourth Amendment and any prior Amendments, the Agreement shall remain in full force and effect according to its terms.


