(Resolution Authorizing Acceptance and Execution of 2026 Community Services Block Grant Agreement with the California Department of Community Services and Development)

WHEREAS, on or about December 15, 2020, Yolo County Health and Human Services Agency (“HHSA”) entered into Agreement No. 21F-4052 with the State of California (“State”) Department of Community Services and Development (“CSD”) for revenue of \$303,665 for the period of January 1, 2021 through May 31, 2022; and

WHEREAS, on or about December 13, 2021, HHSA entered into Agreement No. 22F-5052 with CSD to receive additional revenue of \$302,667 for the period of January 1, 2022 through May 31, 2023; and

WHEREAS, on or about January 18, 2023, HHSA entered into Agreement No. 23F-4052 with CSD to receive additional revenue of \$391,080 for the period of January 1, 2023 through May 31, 2024; and

WHEREAS, on or about March 12, 2024, HHSA entered into Agreement No. 24F-3052 with CSD to receive additional revenue of \$391,080 for the period of January 1, 2024 through April 30, 2025; and

WHEREAS, on or about January 14, 2025, HHSA entered into Agreement No. 25F-6052 with CSD to receive additional revenue of \$398,789 for the period of January 1, 2025 through April 30, 2026;

NOW, THEREFORE, IT IS RESOLVED, ORDERED AND FOUND THAT:

1. The Board of Supervisors delegates signing authority to the Yolo County Deputy Director of General Services/Manager of Procurement, or designee, to execute Agreement No. 26F-5052 to receive funding in the amount of \$398,789 for the period of January 1, 2026 through April 30, 2027, including associated attachments, exhibits, and forms.
2. The Yolo County Deputy Director of General Services/Manager of Procurement, or designee, is authorized to enter into any financial or non-financial amendments and revisions of the Agreement, including attachments, exhibits, and forms, upon approval as to form by County Counsel.
3. The Director of HHSA, or designee, is authorized to prepare and sign any fiscal or program reports required by the Agreement.
