Health and Human Services Program Coordinator (U: Supervisory)	March 22, 2026	-1.0	\$100,048- \$121,618	Deletes one (1) vacant limited-term full-time position (#2725) which was unfunded at 2025-2026 Adopted Budget. The annual fiscal impact is \$110,302.

Emergency Medical Services Program Coordinator (U: Supervisory)	March 22, 2026	1.0	\$101,941- \$123,864	Converts one (1) vacant full-time position from limited-term to regular (#2648).
Office Support Specialist (G: General)	March 22, 2026	-1.0	\$53,664- \$65,229	Deletes one (1) vacant regular full-time position (#2821) which was unfunded at 2025-2026 Adopted Budget. The annual fiscal impact is \$59,155.
Community Health Assistant II (G: General)	March 22, 2026	-1.0	\$45,365- \$55,120	Deletes one (1) vacant limited-term full-time position (#2544) which was unfunded at 2025-2026 Adopted Budget. The annual fiscal impact is \$55,432.
Outreach Specialist II (G: General)	March 22, 2026	-1.0	\$68,328- \$83,075	Deletes one (1) vacant limited-term full-time position (#2833) which was unfunded at 2025-2026 Adopted Budget. The annual fiscal impact is \$75,358.

Public Assistance Specialist II (G: General)	March 22, 2026	-2.0	\$60,486- \$73,507	Deletes two (2) vacant limited-term full-time positions (#3162) which were unfunded at 2025-2026 Adopted Budget. The annual fiscal impact is \$66,685 per FTE.
Employment Services Specialist II (G: General)	March 22, 2026	-1.0	\$68,578- \$83,366	Deletes one (1) vacant limited-term full-time position (#2666) which was unfunded at 2025-2026 Adopted Budget. The annual fiscal impact is \$75,608.
