

**AMENDMENT NO. 2  
to the  
AGREEMENT  
between the  
CITY OF WEST SACRAMENTO  
And  
YOLO COUNTY  
Dated February 25, 2025**

This Amendment No. 2 to the Agreement for Supplemental Law Enforcement Services between the City of West Sacramento and Yolo County dated February 25, 2025, is made and entered into 4<sup>th</sup> day of February, 2026. Except as expressly amended herein, the February 25, 2025 Agreement is in full force and effect.

**RECITALS**

**WHEREAS**, the City of West Sacramento entered into an agreement with Yolo County for supplemental law enforcement services during certain events to be designated by the City of West Sacramento; and

**WHEREAS**, Yolo County was agreeable to providing such services, as authorized in Government Code section 55632; and

**WHEREAS**, the City of West Sacramento desires Yolo County to continue services; and

**WHEREAS**, Amendment 1 was executed on October 7, 2025 to increase compensation by \$125,000.00, not to exceed \$175,000.00; and

**WHEREAS**, additional compensation is needed to continue services; and

**WHEREAS**, the City of West Sacramento and Yolo County desire to amend said contract.

**NOW, THEREFORE, IT IS MUTUALLY AGREED** by parties hereto to amend said agreement as follows:

I. **COMPENSATION:**

The compensation as set forth in the Agreement dated February 25<sup>th</sup>, 2025, shall be revised to include the following:

- a. Agreement compensation shall be increased by \$140,000.00 and total compensation shall not exceed \$315,000.00 without the City of West Sacramento's express written approval.
- b. Agreement Exhibit "A" Service Rates shall be amended with the updated hourly rates for Yolo County Sheriff's Office and Yolo County District Attorney personnel, attached hereto and incorporated herein by reference.
