

## GOVERNING BOARD RESOLUTION

THE BOARD OF SUPERVISORS (GOVERNING BOARD) OF

COUNTY OF YOLO

**HEREBY AUTHORIZES: Submittal of an application to the California Department of Housing and Community Development for funding under the HOME Investment Partnerships Program (HOME); and if selected, the execution of a Standard Agreement, any amendments thereto, and of any related documents necessary to participate in the HOME Program.**

### WHEREAS:

- A. The California Department of Housing and Community Development (the "Department") is authorized to allocate HOME Investment Partnerships Program ("HOME") funds made available from the U.S. Department of Housing and Urban Development ("HUD"). HOME funds are to be used for the purposes set forth in Title II of the Cranston-Gonzalez National Affordable Housing Act of 1990, in federal implementing regulations set forth in Title 24 of the Code of Federal Regulations, part 92, and in Title 25 of the California Code of Regulations commencing with section 8200.
- B. On January 29, 2026, the Department issued a Notice of Funding Availability announcing the availability of funds under the HOME program (the "NOFA"), including HOME Program funds specifically derived from Program Income.
- C. In response to the NOFA, the County of Yolo, a political subdivision of the State of California (the "Applicant"), wishes to apply to the Department for, and receive an allocation of, HOME funds derived from its Program Income.

### IT IS NOW THEREFORE RESOLVED THAT:

1. In response to the above referenced HOME Program Income, the Applicant shall submit an application to the Department to participate in the HOME Program Income and request up to SIX HUNDRED SIXTY-EIGHT THOUSAND FOUR HUNDRED AND THIRTY SEVEN Dollars (\$668,437), of current funds, along with any additional future program income, to support the following activities and programs to be located in the County of Yolo:
  - Owner-Occupied Housing Rehab to assist existing income-eligible homeowners with the repair, rehabilitation, or reconstruction of owner-occupied units; and
  - Tenant-Based Rental Assistance to provide tenants with security deposit assistance, utility deposit assistance and/or monthly rental assistance payments for income-eligible households.

2. If the Application for funding is approved, then the Applicant hereby agrees to use the HOME funds for eligible activities in the manner presented in its Application as approved by the Department in accordance with the statutes and regulations cited above. The Applicant will also execute a Standard Agreement with the Department, any amendments thereto, and any and all other documents or instruments necessary or required by the Department or HUD for participation in the HOME program.
3. The Applicant hereby authorizes and directs the Deputy County Administrator to execute, in the name of the Applicant, the HOME Standard Agreement, other HOME-related contracts and conveyances, and any subsequent amendments thereto.
4. The Applicant hereby authorizes the Deputy County Administrator or their designee, to execute, in the name of the Applicant, drawdown requests and any other HOME Program form requiring a signature, as may be required by the Department from time to time.


