

RESOLUTION NO. _____

(Resolution Increasing Appropriations in the Amount of \$150,000 to the Eligibility & Employment Branch WIOA Cost Center)

WHEREAS, on or about June 9, 2026, the Board of Supervisors for the County of Yolo approved the Recommended Budget for 2026-27 for the Health and Human Service Agency (“HHSA”); and

WHEREAS, the California Public Utilities Commission awarded Yolo County (“County”) HHSA a grant in the amount of \$150,000 in response to HHSA’s project proposal requesting funding to sustain and expand free, in-person public broadband access at the Woodland and West Sacramento Employment Centers for residents lacking reliable home internet; and

WHEREAS, HHSA is requesting approval and authorization for the Chair to sign an agreement with the Public Utilities Commission in the amount of \$150,000 for the period of July 1, 2026 through June 30, 2028 to accept California Advanced Services Fund (CASF) Broadband Adoption Account grant funding for the YoloWorks! Employment Center Broadband Access Project; and

WHEREAS, the additional funding of \$150,000 was not included in the 2026-27 Recommended Budget for HHSA; and

WHEREAS, HHSA is requesting to include the award amount of \$150,000 in the HHSA 2026-27 Recommended Budget; and

WHEREAS, it appears to be in the best interest of the County, its residents, and other customers, to accept the funds; and

WHEREAS, there would be no net fiscal impact to the County General Fund for Fiscal Year 2026-27 by making these adjustments; and

WHEREAS, Government Code section 29130 provides for the appropriation of these funds by a three-fifths vote of the Board of Supervisors.

NOW, THEREFORE IT IS HEREBY RESOLVED, ORDERED AND FOUND by the Board of Supervisors of the County of Yolo, State of California, that the Chief Financial Officer is authorized to increase the recommended budget for fiscal year 2026-27 as follows:
