

**RESOLUTION NO. \_\_\_\_\_**

**(Resolution Increasing Appropriations in the Amount of \$117,973 to the Eligibility & Employment Branch WIOA Cost Center)**

**WHEREAS**, on or about June 9, 2026, the Board of Supervisors for the County of Yolo approved the Recommended Budget for 2026-27 for the Health and Human Service Agency (“HHSA”); and

**WHEREAS**, the California Public Utilities Commission awarded Yolo County (“County”) HHSA a grant in the amount of \$117,973 in response to HHSA’s project proposal requesting funding to support a two-year digital literacy and workforce training initiative; and

**WHEREAS**, HHSA is requesting approval and authorization for the Chair to sign an agreement with the Public Utilities Commission in the amount of \$117,973 for the period of July 1, 2026 through June 30, 2028 to accept California Advanced Services Fund (CASF) Broadband Adoption Account grant funding for the YoloWorks! Digital Literacy Project; and

**WHEREAS**, the additional funding of \$117,973 was not included in the 2026-27 Recommended Budget for HHSA; and

**WHEREAS**, HHSA is requesting to include the award amount of \$117,973 in the HHSA 2026-27 Recommended Budget; and

**WHEREAS**, it appears to be in the best interest of the County, its residents, and other customers, to accept the funds; and

**WHEREAS**, there would be no net fiscal impact to the County General Fund for Fiscal Year 2026-27 by making these adjustments; and

**WHEREAS**, Government Code section 29130 provides for the appropriation of these funds by a three-fifths vote of the Board of Supervisors.

**NOW, THEREFORE IT IS HEREBY RESOLVED, ORDERED AND FOUND** by the Board of Supervisors of the County of Yolo, State of California, that the Chief Financial Officer is authorized to increase the recommended budget for fiscal year 2026-27 as follows:
