Resolution Ordering Fire Commissioner Election and Requesting the Board of Supervisors of the County of Yolo to Consolidate District Election with the Regular Election Held on November 3, 2026.

WHEREAS, a regular biennial election for Commissioners of the Yolo Fire Protection District is to be held on November 3, 2026; and

WHEREAS, it is desirable that the District election be consolidated with the regular election to be held on the same date, and that within the Yolo Fire Protection District the precincts, polling places, and the election officers of the two elections be the same, that the County Clerk of the County of Yolo canvass the returns of the District election, and that the District election be held in all respects as if there were only one election.

NOW, THEREFORE, IT IS HEREBY RESOLVED, ORDERED, AND FOUND By the Board of Fire Commissioners of the Yolo Fire Protection District as follows:

1. Pursuant to Health and Safety Code Section 13885 et seq. and Elections Code Sections 10500 et seq., an election is hereby called and ordered to be held on November 3, 2026 to fill the following offices of the Yolo Fire Protection District Commissioners whose terms expire this year:

One Commissioner: Four (4) Year Term

2. The County Clerk of the County of Yolo (County Clerk) is hereby requested to conduct the election and provide all related election services.

3. The candidates, including incumbents, will pay the costs of publishing the candidate's statement included with the sample ballot, which statement shall not exceed 200 words.

4. The Yolo Fire Protection District hereby elects to resolve a tie vote by lot.

5. The Board of Supervisors of the County of Yolo (Board of Supervisors) is hereby requested to consent, agree to, and order the consolidation of the District's governing board member election with the regular election to be held on Tuesday, November 3, 2026, that only one form of ballot be used, and that the elections be held in all respects as one election.

6. The County Clerk is hereby authorized to canvass the returns of the District election.

7. The Board of Supervisors is hereby requested to authorize and direct the County Clerk to take any and all steps necessary for the holding of the consolidated election.

8. The Yolo Fire Protection District hereby agrees to reimburse the County of Yolo for the costs of such election.

9. This Resolution supersedes and replaces District Board Resolution for November 5, 2024.

10. The Clerk of this Board is directed to file certified copies of this Resolution with the Yolo County Board of Supervisors and the Yolo County Clerk.
